- Gates open 7:30am and close 6:00pm each day.
- All siteholders must complete the <u>online safety induction</u> (Password is 'firstaid')
- All siteholders need to provide an Insurance Certificate of Currency of no less than \$10 million.
- All vehicles must be cleared from the site areas no later than 8:00am each day of the show.
- Bump-in is prior to 10:30pm 18th July 2024 and bump-out is after 4:00pm 21st July 2024 times must be strictly adhered to.
- Siteholders are responsible for providing their own tents/marquees.
